
**ARTICLES OF AMENDMENT



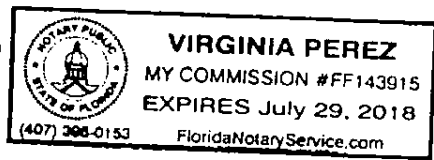
