**ARTICLES OF ORGANIZATION
OF
KLEEN TEEM CLEANING & CONSTRUCTION SERVICES, LLC**

ARTICLE I - NAME

The name of this limited liability company is Kleen Teem Cleaning & Construction Services, LLC.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the Company is 3601 West Devon Avenue, Suite 3, Chicago, Illinois 60659.

**ARTICLE III - REGISTERED AGENT AND OFFICE,
& REGISTERED AGENT'S SIGNATURE**

The street address of the initial registered office of this Company is Golden & La Neve, 644 Southeast Fourth Avenue, Fort Lauderdale, Florida 33301, and the name of the initial registered agent of this Company at that address is E. Scott Golden.

ARTICLE VI - EFFECTIVE DATE AND DURATION

This Company shall exist for a period of fifty years from the filing date of these Articles of Organization. Dissolution shall be as set forth in the Operating Agreement.

ARTICLE VII - INDEMNIFICATION

The Company shall indemnify any officer, member, or manager, or any former officer, member, or manager to the fullest extent permitted by law and according to the Operating Agreement.

ARTICLE VIII - AMENDMENT

The members of the Company reserve the right to amend or repeal any provisions contained in these Articles of Organization, or any amendment thereto, and any right conferred upon the managers is subject to this reservation.


ARTICLE IX - PURPOSE

No member shall have the right to demand the return of his or its contribution to capital, except as provided in the Operating Agreement as then in existence.


