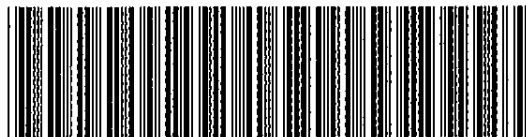

ARTICLE III- Management


