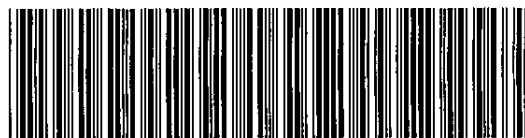

FIRST, the name of the Limited Liability Company is:

BURTTRAM PROPERTY MANAGEMENT, L.L.C.

SECOND, the latest date on which the Limited Liability Company is to dissolve is June 8, 2061.

THIRD, The Limited Liability Company is organized to acquire and manage real property and to engage in and do any lawful act concerning any lawful business, other than banking and insurance, for which a limited liability company may be organized in accordance with Florida Statutes, §§ 608.401 to 608.471, including all powers and purposes now and hereafter permitted by law to a limited liability company.

FOURTH, the street address of the initial registered office of the Limited Liability Company in Florida is: 2750 Woodsmill Drive, Melbourne, Florida 32934 and the name of the initial registered agent of the Limited Liability Company in Florida at the address is **TEDDY S. BURTTRAM**.
