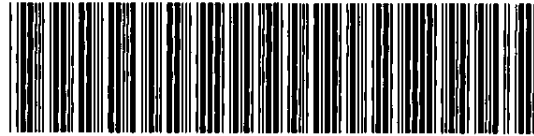

The mailing address and street address of the principal office of the Company is 119 Swan Lake Circle, Birmingham, Alabama 35242.


ARTICLE III - INITIAL REGISTERED OFFICE AND AGENT
