# Articles of Organization of 17460 Duquesne, LLC

### A Florida Limited Liability Company



- 1. Name. The name of this limited liability company is 17460 Duquesne, LLC (the "Company"), and it shall be formed as a Florida limited liability company under Chapter 608, Florida Statutes.
