**ARTICLES OF AMENDMENT
TO

SECOND: The following amendments to the Articles of Organization were adopted by KBS Main Street, LLC.:

1. Article II is hereby revised to change the principal and mailing addresses of the Company as follows:

ARTICLE II -- ADDRESS

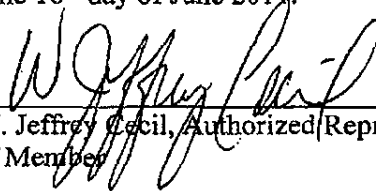
