ARTICLES OF ORGANIZATION
OF

The undersigned, Gregory S. Wilson, Personal Representative, certifies that he is a Manager of St. Pete Police Supply, LLC , a limited liability company formed and existing under the laws of the State of Florida (the "Company"), and hereby further certifies as follows:

1. The name of the Company is St. Pete Police Supply, LLC.
2. The original Articles of Organization of the Company were filed with the Department of State of the State of Florida (the "Department of State") on or about June 14, 2011, and assigned Florida document number L11000069432.

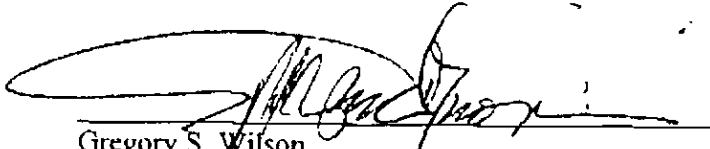
