**ARTICLES OF ORGANIZATION
OF
ARTRECORDS, LLC.**

These Articles of Organization are made for the purpose of organizing a Florida limited liability company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of the company is ArtRecords, LLC (hereinafter called the "Company").

ARTICLE II - INITIAL PRINCIPAL OFFICE

The initial mailing address and street address of the principal office of the Company is 200 SW 30th Road, Miami, Florida 33129.

ARTICLE III - PURPOSE

The Company is organized for the purpose of transacting any or all lawful business for companies organized under the Florida Limited Liability Company Act of the State of Florida.

ARTICLE IV - DURATION

The period of duration of the Company shall be perpetual.

ARTICLE V - INITIAL REGISTERED AGENT

The initial registered agent of the Company is José Alonso. The Florida street address of the initial registered agent of the Company is 200 SW 30th Road, Miami, Florida 33129.

ARTICLE VI - MANAGEMENT

The Company shall be member managed in accordance with the terms and conditions of the Company's Operating Agreement, as amended from time to time. José Alonso is the Company's initial President and Secretary.

ARTICLE VI - INDEMNIFICATION

Section 1. Indemnification. Each person (including here and hereinafter, the heirs, executors, administrators, or estate of such person) (a) who is or was a manager of the Company, (b) who is or was an officer, agent or employee of the Company and as to whom the Company has agreed to grant such indemnity hereunder, or (c) who is or was serving at the request of the Company in the position of a director, officer, trustee, partner, agent, or employee of another Company, partnership, joint venture, trust or other enterprise and as to whom the Company has agreed to grant such indemnity hereunder, shall be indemnified by the Company as of right

to the fullest extent permitted or authorized by current or future legislation or by current or future judicial or administrative decision (but, in the case of any future legislation or decision, only to the extent that it permits the Company to provide broader indemnification rights than permitted prior to the legislation or decision), against all fines, liabilities, settlements, costs and expenses, including attorneys' fees, asserted against him or incurred by him in his capacity as such director, officer, trustee, partner, agent or employee or arising out of his status as such director, officer, trustee, partner, agent or employee. The foregoing obligation of the Company to indemnify shall not be exclusive of other rights to which those seeking indemnification may be entitled. The Company may maintain insurance, at its expense, to protect itself and any such person against any such fine, liability, cost or expense, including attorneys' fees, whether or not the Company would have the legal power to directly indemnify such person against such liability.

Section 2. Advances. Costs, charges and expenses (including attorneys' fees) incurred by a person referred to in Section 1 of this Article in defending a civil or criminal ~~suit~~ ~~action~~ or proceeding may be paid by the Company in advance of the final disposition thereof, upon receipt of an undertaking to repay all amounts advanced if it is ultimately determined that the person is not entitled to be indemnified by the Company as authorized by this Article, ~~and upon~~ satisfaction of other conditions established from time to time by the Members or required by current or future legislation (but, with respect to future legislation, only to the extent that it provides conditions less burdensome than those previously provided).
