**ARTICLES OF ORGANIZATION
OF
Kathy 123, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – Name

The name of the Limited Liability Company is Kathy 123, LLC (the "Company").

ARTICLE II – Address

ARTICLE VIII – Termination of Existence


