ARTICLES OF ORGANIZATION

OF

BKR CONSULTING, LLC

I, the undersigned, hereby make, subscribe, acknowledge and file these Articles for the purpose of becoming a Limited Liability Company under the laws of the State of Florida.

ARTICLE I

The name of the Limited Liability Company is BKR CONSULTING, LLC.

ARTICLE II

The Limited Liability Company shall have perpetual existence.

ARTICLE III

ARTICLE VI


The power to adopt, alter, amend or repeal an operating agreement for the Limited Liability Company shall be vested in the members.


ARTICLE VII


