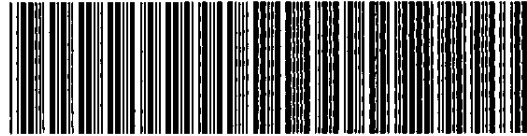


Dear Ms. Bostick,
