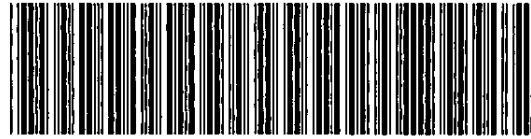

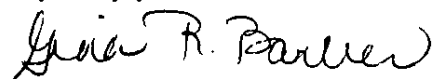

TO THE
ARTICLES OF ORGANIZATION
OF
CJP COLUMBIA PROPERTIES, LLC**

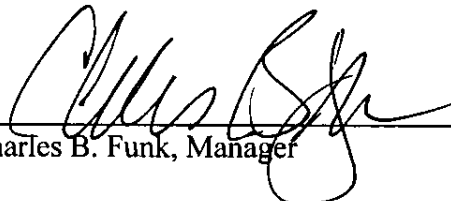
