**ARTICLES OF ORGANIZATION  
FOR THE LIMITED LIABILITY COMPANY  
OF  
YELGAM EFFICIENT SOLUTIONS, LLC**

The undersigned, acting as the organizers of a limited liability company to be formed under the Florida Limited Liability Company Act, as amended (the "Act"), hereby form a Florida Limited Liability Company (this "Company") pursuant to the Act and hereby set forth the following Articles of Organization (these "Articles"):

**ARTICLE I**

**Name**

The name this Company shall be YELGAM EFFICIENT SOLUTIONS, LLC.

**ARTICLE II**

**Commencement Date and Duration**

This Company shall commence upon properly filing these Articles of Organization, subsequent to subscription and acknowledgment in accordance with the provisions of Section 608.409(1) of the Act, and shall continue until dissolved by its members or managers in accordance with Section 608.441 of the Act or the provisions of these Articles. Subject to the foregoing, this Company shall be dissolved on the happening of any of the following events:

1. Withdrawal, retirement, death, resignation, bankruptcy, dissolution or expulsion of any member, unless the business of this Company is continued by the consent of all the remaining members;
2. Unanimous written consent of all the members.

### **ARTICLE III**

#### **Purpose**

This Company is created and formed for the primary purpose of engaging in all lawful businesses authorized for a Company pursuant to Section 608.403 of the Act, including without limitation, sales management consulting and related activities.

### **ARTICLE IV**

#### **Place of Business**

The principal place of business of this Company shall be 6911 River Birch Court, Bradenton, Florida 34202, and such other place or places as may be designated by the members from time to time.

### **ARTICLE V**

#### **Registered Agent and Office**

#### **Admission of Members**

These Articles of Organization, except with respect to vested rights of the member(s), may be amended at any time by vote by a majority in interest of its members, and such amendments shall be filed with the Florida Department of State in accordance with the provision of Section 608.411 of the Act.

## **ARTICLE XI**

### **Regulations**

The members are hereby authorized and directed to prepare and adopt an Operating Agreement and Regulations for the governing of the internal affairs of this Company containing such provisions as they consider necessary, reasonable or desirable, except that no provisions of such Operating Agreement and Regulations may conflict with the provisions of these Articles,


unless otherwise permitted herein. The power to adopt, alter, amend or repeal the Operating Agreement and Regulations shall be set forth in the Operating Agreement and Regulations.

## ARTICLE XII

### Contracting Debts

No debt shall be contracted nor liability incurred by or on behalf of this Company except by its Managing Member as set forth in the Operating Agreement and Regulations properly adopted.

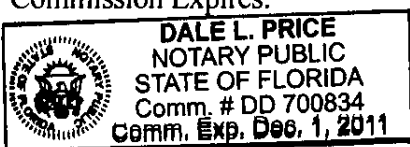
