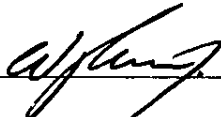

The undersigned, being the organizers of the Limited Liability Company do hereby certify as follows:

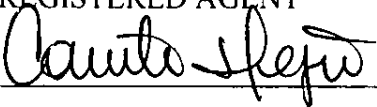
- a. The name of the LLC is: SanMejio, LLC
- b. The principal office of the Limited Liability Company shall be located in the Orange County, Florida. 5157 W. Rio Vista Ave, Tampa, FL 33634
- c. The Limited Liability Company has no specific date of dissolution in the addition to the events set forth in Statutes of the State of Florida. The Limited Liability Company shall dissolve and terminate due to the following event:
 - i. The occurrence of the termination events specified in the Operating Agreement of the LLC. .
- d. Mr. Camilo A. Mejio is designated as the agent of the Limited Liability Company upon whom process against the LLC may be served, and the address to which the Secretary of State shall mail a copy of any process against the LLC served upon him is 5157 W. Rio Vista Ave, Tampa, FL 33634.
The LLC shall be managed by a Manager as designated by the Members. The Manager, William Sanchez, shall have all the responsibilities and benefits as described in the operating agreement.
- e. All of the specified members are to be liable in their capacity as members for all or specified debts, obligations, or liabilities of the LLC as authorized pursuant to Florida Statutes.
- f. The Members of the LLC elect to include the following additional provisions in these Articles of Organization for the regulation of the internal affairs of the LLC:
 - i. The LLC may carry on and engage in any lawful business of purposes permitted under state law. The main business of the company will be the sale and installation of flooring materials
 - ii. The limitations on the authority of Members and/or Managers or a class of Members to bind the LLC are listed in the Operating Agreement
 - iii. The members' share of interest in the company will be as follows:
Flooring Master of Central Florida, LLC, an interest equal to 70%. EWI Flooring Solutions, Inc. an interest equal to 30% for a total of 100% between the two members.
 - iv. The members reserve the right to from time to time revise the provisions set forth in these Articles and in the Operating agreement and make amendments. There will need to be the consent of the majority vote of all membership interest for this purpose.
