The management of the limited liability company shall be vested in its member or members and is, therefore, a member-managed limited liability company.

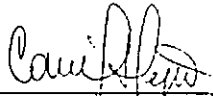

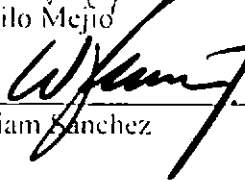
