Operating Agreement

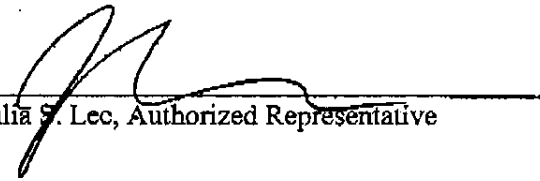

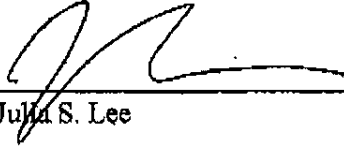
