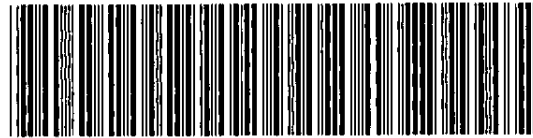

The mailing address and the street address of the principal office of the Company is 1200 Cassat Ave., Jacksonville, FL 32205


**ARTICLE IV
