The Limited Liability Company will be member managed.

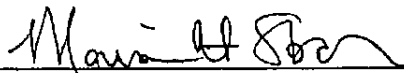

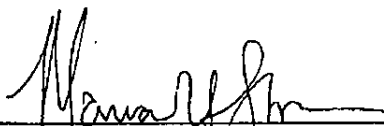
