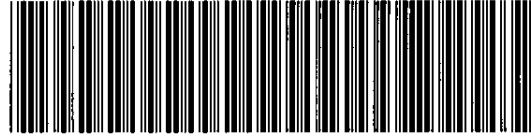

**ARTICLES OF ORGANIZATION  
OF  
FRENCHS 108, LLC**

1. Name. The name of this limited liability company is FRENCHS 108, LLC, a Florida limited liability company (the "Company").

2. Duration. The Company shall have perpetual existence commencing on the filing of the Articles of Organization with the State of Florida and continues even though a membership of a member is terminated.

3. Purpose. The Company is organized to hold and manage real property, transact all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, including invest in, develop, lease, purchase, own, sell or rent real property and make other investments.

4. Place of Business. The mailing and street address of the Company's principal office is 10488 Heritage Bay Blvd, Naples, Florida 34120.

5. Registered Agent and Office. The name of the initial registered agent of the Company is Steven J. Adamczyk, Esq. The street address of the initial registered agent of the Company is Goede & Adamczyk, PLLC, 8950 Fontana Del Sol Way, Suite 100, Naples, Florida 34109.

6. Additional Members. Additional members to the Company may be admitted, but only upon the unanimous consent of all members of the Company at the time admission is sought.

7. Management of the Company. The Company shall be managed by its managers, in accordance with the Regulations adopted by all of the members. The name and address of the manager, who is a member and the only member of the Company is:

8. Voting. The Company is authorized to issue membership interests with voting rights and membership interests without voting rights.

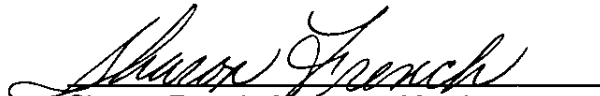
9. Certificated Interests. The members' interests in the Company may be evidenced by certificates.

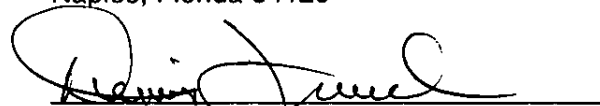

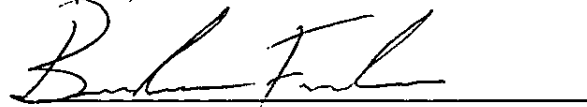
