1. **Name of Limited Liability Company.** The name of the limited liability company is **JVH Holding Company, LLC**, a Florida limited liability company (the "Company").

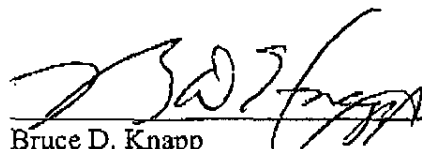
2. **Period of Duration.** The period of duration for the Company shall be perpetual.

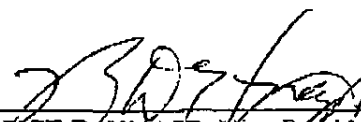
