Orlando Neighborhood Improvement Corporation, a Florida not-for-profit corporation, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I. NAME

The name of the limited liability company is ONIC-BOCA CLUB, LLC (the "Company").

ARTICLE II. ADDRESS

The street address of the principal office of the Company is 101 South Terry Avenue, Orlando, Florida 32805. The mailing address of the principal office of the Company is 101 South Terry Avenue, Orlando, Florida 32805.

ARTICLE III. DURATION

The period of duration for the Company shall be perpetual, unless terminated in accordance with the Company's Operating Agreement or by the written consent of the members of the Company.

ARTICLE IV. INITIAL REGISTERED AGENT AND OFFICE

ARTICLE V. MANAGEMENT

The Company shall be managed by its members and is, therefore, a member-managed company. The initial and sole managing member of the Company is Orlando Neighborhood Improvement Corporation, a Florida not-for-profit corporation.

ARTICLE VI. PURPOSE

The nature of the business and of the purposes to be conducted and promoted by the Company is primarily to own, hold, sell, assign, transfer, operate, manage, lease, mortgage, pledge and otherwise deal with that certain apartment project located at 3114 C.R. Smith Street, Orlando, Orange County, Florida 32805. The Company may otherwise engage in any lawful business permitted by the Florida Limited Liability Company Act (Florida Statutes, Section 608.401 et seq., as amended) or the laws of any jurisdiction in which the Company may do business necessary to satisfy the purpose described herein.

ARTICLE VII. OPERATING AGREEMENT

The power to adopt the Operating Agreement of the Company shall be vested in the members of the Company. The power to alter, amend, or repeal the Operating Agreement of the Company shall be exercised by the members of the Company according to the terms thereof.
