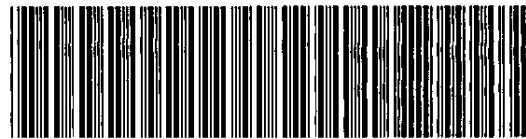

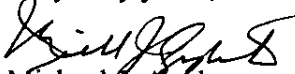

The undersigned, for the purpose of forming a limited liability company pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization:

ARTICLE I

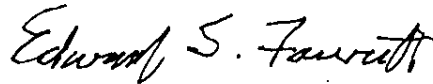
