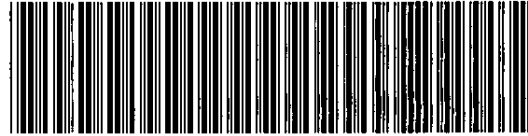

NAME**
