ORGANIZATION OF

The undersigned certify that we have associated ourselves together for the purpose of becoming a Limited Liability Company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the Limited Liability Company.

ARTICLE I
NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the Limited Liability Company shall be Dealerwerx Automotive Selling Solutions, LLC. The right of indemnification provided for above shall not be exclusive of any rights to which any manager or officer of the company may otherwise be entitled by law.


ARTICLE V INITIAL REGISTERED OFFICE AND REGISTERED AGENT
