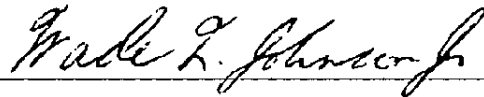
**ARTICLE V.

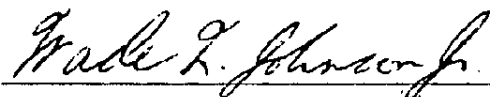
**CERTIFICATE OF DESIGNATION OF
