The Articles of Organization were filed with the Florida Secretary of State on July 5, 2011. The name of the authorized representative and registered agent is incorrect.


The Articles of Organization of Blackstone CFC Holdings, LLC are hereby corrected by deleting in its entirety the present Article III and by substituting therefor the following:


