ARTICLES OF ORGANIZATION OF GRS BROKERAGE, LLC

ARTICLE I - NAME

The name of this Limited Liability Company is GRS BROKERAGE, LLC.

ARTICLE II - ADDRESS AND PRINCIPAL PLACE OF BUSINESS
