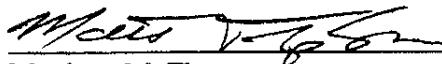
ARTICLE IV

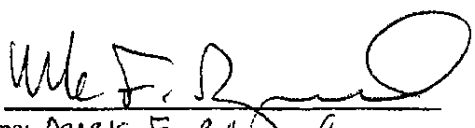
