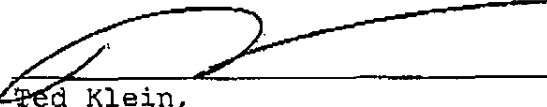
1. The date of the filing of the articles of organization was July 12, 2011. The articles of organization have not been previously amended.
