The undersigned hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

RTGC 46 Management, LLC

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and the mailing address of the Company shall be:

ARTICLE III

Registered Office and Registered Agent

The initial registered office of the Company shall be located at 1201 Hays Street, Tallahassee, Florida 32310, and the initial registered agent of the Company at such office shall be Corporation Service Company. ARTICLE V


Amendment of the Articles of Organization


ACCEPTANCE OF SERVICE AS REGISTERED AGENT
