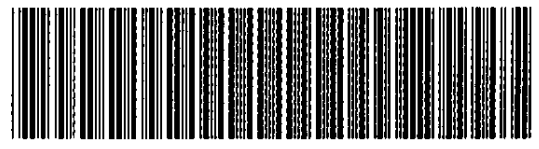

ARTICLES OF ORGANIZATION

of

5458 WILKINS LLC

The undersigned hereby forms and establishes a limited liability company pursuant to Chapter 608, Florida Statutes, as follows:

ARTICLE I

The name of this limited liability company is 5458 Wilkins LLC (the "Company").

ARTICLE IV


