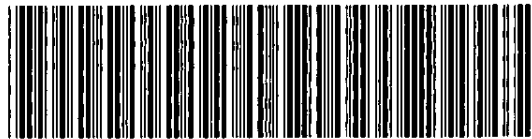

**ARTICLES OF ORGANIZATION**  
**OF**  
**CAMP PALMS @ INDIAN PASS LLC**

The undersigned, under the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

**Article I. Name**

The name of this limited liability company is Camp Palms @ Indian Pass LLC ("the Company").

**Article II. Duration**

Unless earlier terminated under the law or the Operating Agreement, the duration of the Company shall be perpetual.

**Article III. Address of Principal Office**

The street address and mailing address of the principal office of the Company is 985 Indian Pass Road, Port St. Joe, Florida 32456.

**Article IV. Initial Registered Agent and Address**

No additional members shall be admitted to the Company except as provided in the Operating Agreement of the Company. A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or to become a member except as provided in the Operating Agreement.

**Article VI. Written Operating Agreement**

Any operating Agreement entered into by the members of the Company, and any amendments or restatements thereof, shall be in writing, and shall govern all matters relating to the governance of the affairs of the Company, the conduct of its business, and the relations of its members, including without limitation the amendment of these Articles. No oral agreement among the members or managers of the Company shall be deemed or construed to constitute any portion of, or otherwise affect the interpretation of, any written operating agreement of the Company.




**CERTIFICATE OF DESIGNATION OF
