**ARTICLES OF ORGANIZATION  
OF  
360 PHYSICIAN ALLIANCE, LLC**

1. Name. The name of this limited liability company is **360 PHYSICIAN ALLIANCE, LLC**, a Florida limited liability company (the "Company").

2. Duration. The Company's existence shall commence on the date these Articles of Organization are filed and shall thereafter have perpetual existence.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Business. The mailing and street address of the Company's principal office is 11120 Libby Road, Spring Hill, Florida 34609, ATTENTION: Gerald W. Beinhauer, Jr., M.D.

5. Registered Agent and Office. The initial registered office of this corporation shall be located at 401 East Jackson Street, Suite 1700, Tampa, Florida 33602 and the initial registered agent of this corporation at such office shall be Joseph Rugg. The Company shall have the right to change such registered agent and such registered office from time to time, as provided by Florida law.

6. Contributions to the Company. No cash or property (other than cash) has been contributed to the Company by its members at this time. No contributions have been agreed upon.

7. Additional Members. Additional members to the Company may be admitted, but only upon the consent of the members of the Company at the time admission is sought.

8. Termination of a Member's Membership. The death, retirement, resignation, expulsion, bankruptcy, or dissolution of any member or the occurrence of any other event that terminates the continued membership of any member shall not cause the Company to be dissolved, and upon the occurrence of any such event, the Company shall be continued without dissolution.

9. Management of the Company. The Company shall be managed by a Board of Managers in accordance with the operating agreement adopted by all of the members. Until and unless changed in accordance with the operating agreement, the initial Board of Managers shall be Syed W. Ali, M.D., Gerald W. Beinhauer, Jr., M.D., Vincent T. Buckman, M.D., Srinivas Dutt, M.D., Muhammed Hiba, M.D., Melvin C. Lu, M.D., and Simrita Sidhu, M.D.
