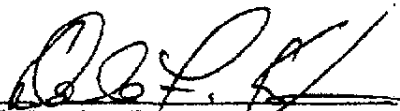

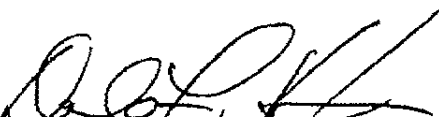
Affiants Dale F. Klco, Individual and Dale F. Klco, President of Gulfstream Electric, Inc. attests that:
