### ARTICLES OF ORGANIZATION

OF

### GDI GP MEMBER, LLC

The undersigned, acting as the organizer of GDI GP MEMBER, LLC under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

### ARTICLE I - Name:

The name of the limited liability company is GDI GP MEMBER, LLC (the "Company").

### ARTICLE II - Address:
