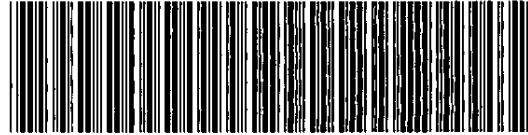

ARTICLES OF ORGANIZATION
OF

ARTICLE I - NAME

The name of the Florida limited liability company shall be J AND J EVENTS AND PROMOTIONS, LLC.
