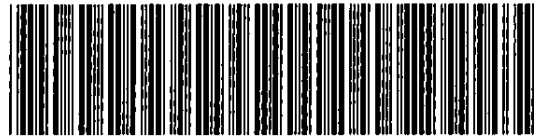

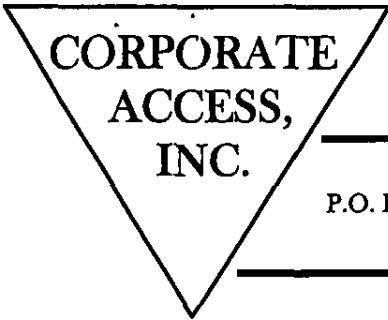

Article 1. - Name
