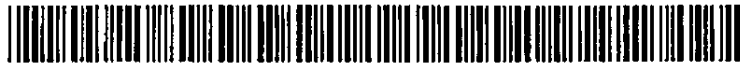


The name of the limited liability company is CENTRAL WAREHOUSE REPH, LLC.
