**ARTICLES OF AMENDMENT
OF
ARTICLES OF ORGANIZATION

Pursuant to Section 605.0202(2) and Section 605.04073, Florida Statutes, Speed Wash & Lube LLC, a Florida limited liability company (the "Company"), submits for filing the following Articles of Amendment to its Articles of Organization:

(1) The Articles of Organization for the Company were filed on July 19, 2011, with an effective date of July 15, 2011, and assigned Florida Document No. L11000082636.

(2) Article V of the Articles of Organization of the Company is hereby amended to read in its entirety as follows:

ARTICLE V - MANAGEMENT

The management of the Company shall be vested in a manager or managers, and the Company shall be a manager-managed company. Accordingly, no member of the Company shall be an agent of the Company solely by reason of being a member. The manager or managers may be chosen, or removed without notice or cause, at any time by the consent of the member or members holding more than 50% of the then-current percentage or other interest in the profits of the Company owned by all of its members.


