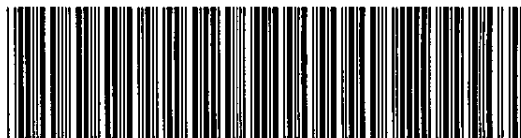

(b) Majed A. Abuamaish, acting alone as Manager of the Company, may enter into other transactions on behalf of, or otherwise act for or bind, the Company.


**FIFTH:** This Statement of Authority also limits the authority of specific persons as follows:


