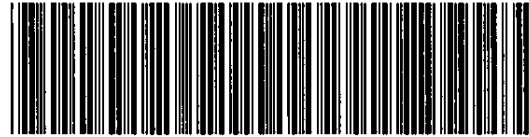

Pursuant to the provisions of the Florida Statutes Section 608.411, FOUR FUTURES, L.L.C., a Florida Limited Liability Company, whose Articles of Organization were filed with the Florida Department of State on July 19, 2011, hereby adopts the following Amendment to its Articles of Organization of the Company:

1. Article III, EXERCISE OF POWERS, of the Articles of Organization of the Company shall be amended and restated as follows:

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of, the managers of this limited liability company. Either manager shall have the power to execute any and all documents on behalf of the company, and shall have the authority to bind the company to any and all agreements without the consent of a majority in interest of the other Members of the Company. All instruments and documents providing for the acquisition, mortgage, or disposition of property of the Company shall be valid and bind the Company if they are executed by one or more managers of the Company.

2. Article IV, MANAGEMENT, of the Articles of Organization of the Company shall be amended as follows:
