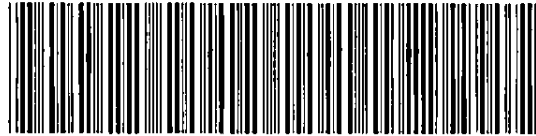

The undersigned, being duly authorized, on behalf of **MNAYMNEH LIFE INSURANCE TRUST FBO JIHAN, LLC**, a Florida limited liability company (the "Converting Entity"), and for the purpose of converting the Converting Entity from a Florida limited liability company into a Delaware limited liability company pursuant to § 605.1045 of the Florida Revised Limited Liability Company Act (the "FLLCA"), certifies that:

1. The name of the Converting Entity immediately prior to the filing of this Articles of Conversion was **MNAYMNEH LIFE INSURANCE TRUST FBO JIHAN, LLC**.
2. The Converting Entity is a Florida limited liability company, formed under the laws of the State of Florida on July 19, 2011.
3. The name of the limited liability company as set forth in the Certificate of Formation, in accordance with the Delaware Limited Liability Company Act is **MNAYMNEH LIFE INSURANCE TRUST FBO JIHAN, LLC**, a Delaware limited liability company (the "Resulting Entity").

5. The Agreement and Plan of Conversion was approved in accordance with §§ 605.1041 – 605.1046 of the FLLCA.

7. The Resulting Entity has agreed to pay any members having appraisal rights the amount to which they are entitled under § 605.1006 and §§ 605.1061 – 605.1072 of the FLLCA.
8. The effective date of the conversion shall be the date of the filing of these Articles of Conversion with the Department of State of the State of Florida.
