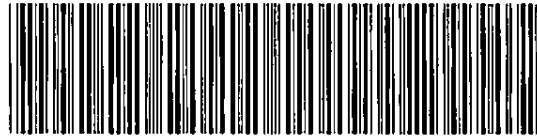

**ARTICLES OF CONVERSION
FOR
MNAYMNEH 2002/2011 CHILDREN'S TRUST, LLC
A FLORIDA LIMITED LIABILITY COMPANY,
INTO
MLDJ 2002 CHILDREN'S TRUST, LLC
A DELAWARE LIMITED LIABILITY COMPANY**

The undersigned, being duly authorized, on behalf of **MNAYMNEH 2002/2011 CHILDREN'S TRUST, LLC**, a Florida limited liability company (the "Converting Entity"), and for the purpose of converting the Converting Entity from a Florida limited liability company into a Delaware limited liability company pursuant to § 605.1045 of the Florida Revised Limited Liability Company Act (the "FLLCA"), certifies that:

1. The name of the Converting Entity immediately prior to the filing of this Articles of Conversion was **MNAYMNEH 2002/2011 CHILDREN'S TRUST, LLC**.
2. The Converting Entity is a Florida limited liability company, formed under the laws of the State of Florida on July 19, 2011 and assigned Document Number L11000083300.
3. The name of the limited liability company as set forth in the Certificate of Formation filed in accordance with the Delaware Limited Liability Company Act is **MLDJ 2002 CHILDREN'S TRUST, LLC**, a Delaware limited liability company (the "Resulting Entity").
4. The above referenced Florida limited liability company has converted into a Delaware limited liability company in accordance with Chapter 605 of the Florida Statutes, and the conversion complies with Chapter 18 of the Delaware Statutes governing limited liability companies.
5. The Agreement and Plan of Conversion was approved in accordance with §§ 605.1041 – 605.1046 of the FLLCA.
6. The Resulting Entity hereby appoints the Secretary of State of the State of Florida as its agent for service of process in a proceeding to enforce obligations of the Converting Entity. For purposes of § 605.0117 and Chapter 48, the Department of State may contact the Resulting Entity at c/o CT Corporation System, 1200 South Pine Island Road, Plantation, FL 33324.
7. The Resulting Entity has agreed to pay any members having appraisal rights the amount to which they are entitled under § 605.1006 and §§ 605.1061 – 605.1072 of the FLLCA.
8. The effective date of the conversion shall be the date of the filing of these Articles of Conversion with the Department of State of the State of Florida.
