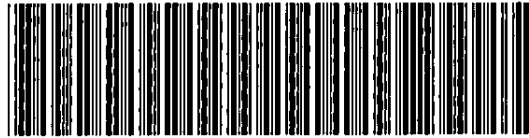

ARTICLES OF ORGANIZATION
OF
PALMA CEIA PUB & PATIO, LLC

1. Name. The name of this limited liability company is **PALMA CEIA PUB & PATIO, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company shall exist effective as of July 18, 2011 and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. Place of Principal Office. The street address of the Company's principal office is 920 Clearwater-Largo Road North, Clearwater, Florida 33770. The mailing address for the Company is Post Office Box 818, Clearwater, Florida 33757.

6. Management of the Company. The management of the Company shall be vested in the managers of the Company. The names and addresses of the initial managers of the Company are as follows:
