#### **ARTICLES OF ORGANIZATION**

#### <u>OF</u>

#### MAGIC FONDUE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization:

#### ARTICLE I

#### NAME OF THE LIMITED LIABILITY COMPANY

The name of this Limited Liability Company shall be MAGIC FONDU

#### ARTICLE II

#### <u>ADDRESS</u>

The mailing address and street address of the principal office of the Company shall be 832 Historian Street, Raleigh, NC 27603.

#### ARTICLE III
