ARTICLE I - NAME

The name of the limited liability company shall be SS 1417, LLC ("company").

ARTICLE II - ADDRESS

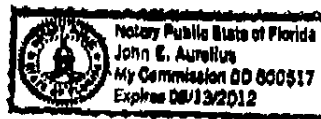


