**ARTICLES OF ORGANIZATION  
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be SS 850-833, LLC ("company").

**ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the company is 1527 SW 1<sup>ST</sup> Avenue, Fort Lauderdale, Florida 33315.

**ARTICLE III - DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved earlier.

**ARTICLE IV - REGISTERED OFFICE AND AGENT**

The company shall be managed by its managing member and its manager. Either the managing member or the manager, signing singly, shall have the full authority to manage the company with or without joinder of the other and each shall have the authority to execute any and all documents on behalf of the company.





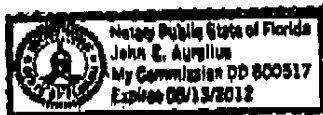
