**ARTICLES OF ORGANIZATION
OF
JSTOTTLER, LLC**

The undersigned person hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 608 of the *Florida Statutes*.

ARTICLE I - NAME

The name of this limited liability company shall be JSTOTTLER, LLC (the "Company").

ARTICLE II - DURATION

The Company shall commence upon execution of these Articles and shall exist perpetually.

ARTICLE III - PURPOSE

The purpose of the Company is to engage in any lawful business activity that is not prohibited with respect to a limited liability company organized according to the laws of the State of Florida.

The initial street and mailing address of the principal place of business of the Company is 1115 South Brevard Avenue, Cocoa Beach, FL 32931.


ARTICLE V - REGISTERED AGENT
