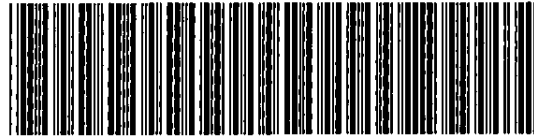

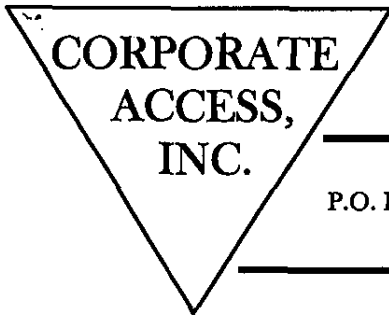

ARTICLE I. NAME


